- \*\*\*MOST BDS Requirements Effective January 1, 2016\*\*\* Recently adopted changes to the national referral rules require members to meet a list of minimum criteria to be eligible for dispatch from the primary list starting January 1, 2016. If you need any classes please contact the union hall as soon as possible to register for the next available training session. - \*\*\*MOST Annual Drug Testing Reinstated\*\*\* The MOST Board of Trustees have amended the Drug Policy to include annual testing. This new policy took effect on August 31, 2015.
